- Each Board member was presented a copy of the "Independent Auditors Report and Financial Statements".
- The Change in Net Position for 2022 was a loss of \$5,034,364 notwithstanding the net income loss, Grand River's financial situation was considered to be strong with 201 Days Cash on Hand, a current ratio of 5.5, and account receivable of 40 days.
